

The Municipality of Stara Pazova



Welcome to the Municipality of Stara Pazova

The Municipality of Stara Pazova is located in the southeastern part of Srem, in the Autonomous Province of Vojvodina occupying the northern part of Serbia. The geographical position of the municipality is exceptionally favorable - it is located between the two largest cities in the country, more precisely, it is 30 km away from the capital of Belgrade and 40 km away from Novi Sad. All major roads in the region cross the territory of the Municipality of Stara Pazova, including state road of IA order A3 highway Belgrade-Zagreb (E-70), IA order A1 highway Belgrade-Novi Sad (E-75) as well as regional roads IIA order 127 Putinci - Stara Pazova - Stari Banovci) and IIA order 128 (Golubinci - Pećinci). The municipality is also covered by significant international railroads leading to Subotica and continuing to Hungary and Germany to the north, as well as towards Niš and continuing to Greece to the south. Belgrade airport "Nikola Tesla", the most important airport in Serbia, is 15 km away and Batajnica military airport, the future cargo center, is only 8 km away from the center of Stara Pazova. The Danube River flows along the eastern border of the municipality in a length of 24 km,





The Municipality of Stara Pazova includes **9 settlements**, three of which are of urban type - **Stara Pazova**, **Nova Pazova and Novi Banovci**, while the remaining six are of rural character - **Golubinci**, **Vojka**, **Stari Banovci**, **Belegiš**, **Surduk**, **and Krnješevci**. The territory of the municipality covers an area of **351 km2**. According to the population census taken in October 2011, the population of the municipality of Stara Pazova reaches almost **68,000**.







Business environment



The Municipality of Stara Pazova has been known for private entrepreneurship for decades. More than 40 years ago, many craft shops were opened making Stara Pazova one of the first and most successful cities in the field of small economy in the former Yugoslavia. Today in the municipality there are more than 1,160 companies and around 2,150 proprietorship businesses. The total number of businessmen and entrepreneurs in the Municipality of Stara Pazova is 3,310.

Various industrial activities are present in the municipality: metalworking, metal, plastics, rubber, woodworking, construction and others.













The basic orientation in agriculture is crop farming - wheat, corn, sunflower, barley, soybeans, sugar beet; also, cattle breeding is represented, mainly breeding of cattle, cows, and pigs.

In the territory of the Municipality of Stara Pazova, there are 1,750 registered agricultural farmsteads.





Dual education - a path to qualified staff for the economy

Dual education in the municipality of Stara Pazova is for the first time implemented in the Secondary Technical School in the school year 2016/2017 in the form of practice and execution of tasks in vocational subjects by selection in three-year and four-year profiles. About 100 students are assigned to proprietorship businesses and companies where they acquire practical knowledge that significantly influences the increase in the emplo yment rate, and through the formation of the future "Training Center," all profiles acquire practical knowledge for all jobs in mechanical engineering and metalworking as well as for CNC operators – programmers



Industrial zones

In the territory of the Municipality of Stara Pazova, there are currently four industrial zones on the surface area of about 1,550 ha. The existing zones are equipped with infrastructure and fully meet the needs of some of the world's most successful companies that have built their plants here: Lidl, Delhaize, Delta Transportni sistem, Eyemaxx, Mercedes-Benz, Nestle, Volvo, Husqvarna, Gorenje, DHL, Muhlbauer, Alumil, Milšped, Grubin, Greiner and JP Packaging, Artinvest, Scania, Bellanta, Pneumo-Logic, ReissWolf, Obo Bettermann, Streit Nova, Delmax, Plados-Telma, Bela Harmonija.

As the capacities of the existing industrial zones have been used, a new Spatial Plan of the Municipality of Stara Pazova is in the development phase. It will enable further economic development by creating new and expanding existing industrial zones in the three settlements.

GREENFIELD locations

In the Central working area there is a Greenfield location of **50.000m**² not adequately equipped with infrastructure currently, but according to the planning document, in the corridor of this street it is planned to build a complete utility infrastructure (electricity, water supply, stormwater and sanitary sewer system, telephone and road) to which future users will be connected.

The mentioned site is located in the northern part of the central working zone, by the state road of I A order A1 (highway Belgrade - Novi Sad E75), in the vicinity of the state road of IA order A3 (highway Belgrade - Zagreb E70) and less than 10 km away from the Batajnica airport – the future cargo center.



Facilities located in this area are: Lidl, Delhaize i DTS.


